ORDINANCE NO. 2009-01

AN ORDINANCE AUTHORIZING THE PRESIDING OFFICER OF THE SANGGUNIANG BAYAN TO REALIGN THE AMOUNT OF ONE HUNDRED EIGHT THOUSAND PESOS (P108,000.00), REPRESENTING THE BALANCE OF APPROPRIATION FROM THE PURCHASE OF AIRCONDITIONING UNITS UNDER THE SB CAPITAL OUTLAY AND AUGMENT THE SAME AMOUNT FOR THE IMPROVEMENT OF THE SB SESSION HALL, UNDER THE SAME EXPENSE CLASS OF THE SAME OFFICE, IN ACCORDANCE WITH R.A. 7160

Be it ordained by the Sangguniang Bayan of Malapatan, Sarangani Province, that:

Section 1- Use of Savings and Augmentation. In accordance with section 336 of R.A. 7160, otherwise known as the Local Government Code of 1991, the “...*Presiding Officer of the Sanggunian concerned may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations*”.

For this purpose, “savings” refers to portions or balances of any programmed appropriation free from any obligation or encumbrance, still available after the satisfactory completion or the unavoidable discontinuance or abandonment of the work, activity or purpose for which the appropriation is authorized.

“Augmentation” implies the existence in the budget of an item, project, activity or purpose with an appropriation which, upon implementation or subsequent evaluation of needed, resources, is determined to be deficient;

Section 2- Source of Funds. The source fund of is the balance of programmed appropriation which is the purchase of airconditioning units for the Sangguniang Bayan Session Hall, amounting to One Hundred Eight Thousand Pesos (P108,000.00) under the Sangguniang Bayan Capital Outlay.

Section 3- Priority Use of Fund. The amount of One Hundred Eight Thousand Pesos (P108,000.00) is hereby realigned, augmented and appropriated for the improvement of the Sangguniang Bayan Session Hall, under the same expense class of the office.


Section 4- Separability Clause. If, for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.





Section 5- Effectivity. This Ordinance shall take its effect immediately.

ENACTED by the Sangguniang Bayan of Malapatan, Sarangani Province, in its 1st Special Session held on June 2, 2009, on motion of Hon. Felipe O. Pulanco, unanimously seconded.
